## Five Decades in Bay Creek

By the time you read this article, Bob Lockhart will have celebrated his 90th birthday on May 27th. Bob has lived in Bay Creek for over half of his 90 years; he purchased his home on Cedar St. in 1971. Before moving to Bay Creek, Bob and his partner, Clarence Cameron, were living on the 600 block of University Ave. The City paid them to move in preparation for a planned redevelopment of that area.

Bob is a native of Montpelier, Ohio, a small town approximately 90 miles southeast of Ann Arbor, Michigan. When Bob was in high school, he and his younger sister (and only sibling) Jean were taking music lessons from the wife of the school's band director. Bob was planning to go out for football but the band needed a French horn player so he took that opportunity to avoid being pummeled on the field; a choice he is pleased with to this day.

He attended Denison University in Granville, Ohio for two years until he could get into the University of Michigan as an out of state student. Bob's college years were interrupted when he was drafted into the Army for two years. Being in the Army provided Bob with an opportunity to travel, he was in London in 1953 when Queen Elizabeth II was crowned.

After getting out of the Army, Bob returned to the University of Michigan to finish his degree in architecture. He never

got a license so refers to himself as a 'graduate architect' rather than an 'architect'. During his career, Bob was self-employed and focused on designing homes.

After college Bob apprenticed in architect Herbert Fritz's studio, at Hilltop near Taliesin. Herbert was a student of Frank Lloyd Wright. The only option for bathing was the Wisconsin River or the cold water showers at nearby Governor Dodge State Park. Bob would come into Madison periodically to visit friends and take a hot shower. One of the friends he visited was a mutual friend of Clarence's and wanted to introduce them. Clarence recalls that it took 5 attempts before they finally met 1962. Neither of them had any idea that they would still be together 57 years later.

Bob had a convertible when he and Clarence met and they took what they call their **(Continued on page 2)**

**Senior Lunch Program:** NewBridge Madison invites older adults to enjoy a nutritious lunch at Romnes Apartments, 540 W. Olin Avenue, at 11:30 am Monday through Friday. Our lunches are provided on a donation basis for persons age 60 and older, with a suggested donation of \$4.00. Others who attend the meals are asked to pay \$8.97. Meals must be reserved no less than 24 hours in advance. Call NewBridge at (608) 512-0000 for more information or to reserve meals. Door-to-door transportation is also provided for South Madison seniors through Transit Solutions for a \$1.00 round-trip donation. Contact Transit Solutions directly to set up a ride by calling (608) 294-8747.

**Farmers Market Voucher Distribution:** Starting in June, the Area Agency on Aging of Dane County will distribute farmers market vouchers to eligible seniors at locations around Dane County. A set of vouchers is worth \$25 toward the purchase of fruit, vegetables, or herbs at Farmer's Markets during the 2019 season. You are eligible if you are 60 or older, live in Dane County, and have a gross income of less than \$23,170 per year for one person or \$31,284 for two-person households. There is a limit of one set of vouchers per household, no matter what size the household. When picking up vouchers, you will need to complete a short application and sign it, to self-declare that you are eligible. Distribution is on a first-come, first-served basis.

- Romnes Apartments, 540 W. Olin Ave. on Wednesday, June 19 from 2:00-3:00 pm.

In addition to the 1962 World's Fair, they attended the World's Fairs in Montreal and New York City. They have also traveled to Puerto Rico, Costa Rica and Mexico. This is all in addition to the traveling they have done around the country exhibiting Clarence's work at art fairs.

Bob has not traveled as much in recent years although he and Clarence did go to Washington DC in 2008 for President Obama's inauguration. Clarence has relatives in Georgetown so they were also able to get into one of the inaugural balls, something I would imagine very few Bay Creek residents have experienced.

Bob and Clarence are grateful that they have been able to live as a gay couple without any major problems. Both sets of parents and other family members accepted their relationship. When Bob would return to Ohio to attend his high school reunion, Clarence would travel with him. During one trip, a classmate of Bob's shared that he had been struggling with the fact that his son was gay but seeing Bob and Clarence's relationship made it easier for him to accept.

Bob's upbeat personality and ready smile have endeared him to many of us in Bay Creek. (Not to mention his chili and cornbread which is a perennial hit at our January potluck). Happy 90th Birthday to Bob from all of his friends in Bay Creek. ❖

# BCNA Meeting Minutes May 9, 2019

Facilitator Jane Smith called the meeting to order shortly after 6:00. Jane began the meeting by summarizing BCNA's Guidelines for Civil Discourse.

**Famous Dave's:** Aaron Dach and Desiree Schroeder spoke about the upcoming changes at Famous Dave's, 900 S. Park St. This location, which has been on Park St. for 22 years, is being taken over by Famous Dave's corporate office. The new ownership will allow for some updates and remodeling to be done. It will also require a change in the liquor license. This location has served liquor (beer and wine) in the past and is reapplying for the permit under the new ownership. Aaron will be named as liquor agent. Famous Dave's corporate office is taking over locations in Janesville and Greenfield WI as well. There will also be some minor changes to the menu, including babyback ribs being on the menu again. A BIG thank you to Aaron and Desiree for bringing food so people could sample what the restaurant has to offer.

## COMMITTEE UPDATES

**SMPC:** Lisie Kitchel reported that South Madison Unite is hoping to get SMPC's endorsement and backing on the efforts that are being made to keep a grocery store open on S. Park St.

**FOOT:** Andria Blattner reminded people that the FOOT Spring Concert Series is taking place on May Wednesdays. The first concert was not well attended due to cold rainy weather. Andria also noted that Ron Shutvet would be leading his popular history walk for the May Bird and Nature Walk. The 6/8/19 Bird and Nature Walk will be led by Emily Steinweher of the Aldo Leopold Center. Volunteers are digging up the honeysuckle in the prairie at Olin Turville. If interested in joining this effort, please contact Andria at ablattner22@charter.net or (608) 255-8001.

**Friends of Monona Bay (FOMB):** Lisie Kitchel explained that our new Mayor, Satya Rhodes-Conway, is working to improve the water quality in our lakes. One of the ways that this is being addressed is reallocating hours for street sweeping crews so streets can be cleaned more often. Cleaner streets mean less runoff which leads to cleaner lakes. Another issue impacting water quality is trash generated by construction on the Peloton at Park St. and Fish Hatchery Rd. Trash was visible in the streets after the last storm due to the high winds. Because of the location of the Peloton, the trash blew right down Parr St. which is a primary inlet to Monona Bay. Lisie urged those present to notify the City if they notice trash coming from the project site or the storm sewer at Parr St.

Lisie also reminded people about the clean ups that are organized by FOMB. These take place on the 2nd Saturday of each month from 10:00 a.m. to noon, see Billboard on Page 1 for more details.

**Planning and Economic Development (P&ED):** New Chair Jesse Laz-Hirsch explained that a permit to allow 702 Spruce St. to be a two-unit building was turned down by the City. The property was converted to a two unit without permission from the City. The new owner, Kai Biu Shu, purchased the property with the intention of using it as a rental property and he asked for BCNA's support with getting a permit that would allow him to use the property as

a two-flat building. The City did not grant a special exemption. Jesse is going to check with new Alder Tag Evers to see if there are any options we can help Mr. Shu pursue with the City. Jesse also explained that in the new Request For Proposals (RFP) for the Truman-Olson site, the Traffic Commission has changed the language about the intersection of Cedar, Beld and Park Streets. The original proposal indicated that Cedar would be continued across Park. The language of the current proposal still notes that there will be a street on the west side of Park to allow for access to the new grocery store planned for the site. The change is significant because if the City is not requiring that Cedar be extended across Park, that will shorten the timeframe of the project considerably.

**Newsletter:** Judy Robinson informed those present that the deadline for the June/July issue is Friday, May 24th. Distribution will be the first week of June.

**Treasurer:** Judy also provided the annual Treasurer's report. Please see article on page 4 for more information.

**Neighborhood Association Training:** The City has awarded a grant to fund Neighborhood Association (NA) training so NAs can learn best practices for managing their organizations. Carrie Rothburd helped write the grant and she explained that Arbor Hills NA is currently set to manage the grant but there is a possibility they may opt not to take on the responsibility. She clarified that there is already a tentative budget in place so the management would consist primarily of keeping a record of the expenses for the City. Carrie asked those present to vote on whether BCNA should agree to manage the funds if needed. The motion passed.

**Hope Haven (formerly called Chris Farley House):** Judy Robinson read an e-mail from Mary Stalowski, the Operations Manager at Hope Haven on the project on Olin Ave. The mail noted that both buildings are vacant and that the Madison Fire Department will conduct firefighter training in the structures in mid-May. Demolition is tentatively scheduled to begin May 20.

**Neighborhood Council:** The current bylaws require that there be a quorum (simple majority) of Neighborhood Council members present whenever there is an item that is to be voted on by the general membership. The Council consists of officers, area reps and committee chairs. The topic was brought up for discussion because no Council members were available to attend the April 8 BCNA meeting at which items to be voted on were on the agenda. Discussion focused on the role of the Council and if electronic voting (via e-mail or other methods) should be allowed as well as how to manage that. It was agreed that it is ideal to have people attend the meetings but those present acknowledged that there are other ways for people to be engaged in the neighborhood. It was decided that this is a topic that requires more discussion and that it will be an evolving issue for BCNA.

**Monthly Meetings:** Due to the increase in development and other issues facing the neighborhood, it was once again proposed that BCNA switch to monthly meetings. This generated additional discussion about the role of the Neighborhood Council and how monthly meetings would impact what is required of Council members. The argument was made that it may not be fair to change the requirements now as people were just elected or re-elected to their current positions in March. Another argument was that this has been tried in the past and attendance was low. **(Continued on page 4)**

After much discussion, the motion was made that BCNA would meet monthly with the odd numbered months being 'General Business' and the even numbered months being 'Emergent Issues' meetings. The motion passed. The new schedule will begin with the 6/13/19 meeting.

Jesse Laz-Hirsch tentatively agreed to facilitate the meeting on 6/13/19, Linda Baumann agreed to be back up facilitator if needed. Linda also agreed to facilitate the 7/11/19 meeting.

The meeting was adjourned at 7:47.

## FOOT Notes

We had another cold spring this year but now all is green and flowering. The birds that we watched migrate through in waves are spread out over the landscape nesting and soon to be feeding chicks. They seem much scarcer, so how do we know where to go to find them? One of the best ways to know the whereabouts of birds is to become familiar with eBird. This is the massive database started in 2002 by the Cornell Lab of Ornithology. Every birdwatcher can submit a bird list, the date and location. There is now data from over 25 million lists worldwide. From these lists, amazing maps are created that show the actual migrations of birds day by day like a video. You can look up any park or a location anywhere in the world to see what birds are currently present. There are also bar graphs that show the frequency of any species during the whole year. This is an amazing tool and of, course, there is an app for it. Just google "eBird".

Earlier this spring the no-mow section of Olin Park between the pavilion / playground and the border with Turville was burned. It is really beautiful now and we will see a succession of oak savannah plants flower through the summer. This area has been the project of several work days focusing on getting rid of burdock and the efforts have paid off. There are only a

Just for the fun of it I suppose, there was no way he could have carried off a groundhog. He perched for a while, observing; then flew off. The woodchuck was unaffected.

Unfortunately the bluebird trail is now a Tree Swallow trail. There are no bluebirds nesting. There was one exploring a nest box early in the spring but after the cold snap tree swallows took over.

Yoga in the pavilion will continue on Tuesday evenings. That will be on July 2, 9, 16, and 23 starting at 5:30. The instructor is Samantha Kellogg who is trained in Alignment Yoga. The class is open to all levels. It is a beautiful, peaceful place to practice yoga.

In the last issue of the newsletter, I asked people to donate to save four ash trees on South Shore Drive.

We need to treat the ash trees every three years to protect them against the emerald ash borer.

If they are not treated, the City will cut them down.

There is a different cost for each tree, depending upon its girth. The total amount needed this year is \$774 and we had already raised \$200. We have raised an additional \$230 so we only need \$344 to reach our goal. Please consider contributing whatever you can afford, every little bit helps.
