(to protect our lakes) are now year around. In other words, Bay Creek residents who minded the no parking signs for a four-hour period once a week up until November 15 will NOW BE REQUIRED to abide by that same restriction year around. Please sign up for email and text message alerts regarding snow emergency declarations at: https://www.cityofmadison.com/residents/winter/

Remember, it's hard on many of us when winter starts. Look out for your neighbors. Offer to shovel for that friend who can't. Be careful when driving, go slow and watch for pedestrians and bicyclists. **Grocery Store Update** – As you no doubt have heard, city staff have recommended that we select Rule Enterprises to build the grocery store complex on Truman Olson. I enthusiastically support this decision because this is our best bet at having a full-service supermarket in place before Pick 'N Save closes its doors. A rough timeline would be for Rule to start construction in the Winter/Spring of 2021 with a completion date of Spring/Summer 2022.

Yes, it's concerning that Rule has not yet identified a grocery store, which is why there's a back-up plan in place. Gorman & Co. also had a strong proposal, with (Continued on page 2)

# **BCNA** Meeting Minutes November 14, 2019

**Bylaw Clarification / Discussion** – Neighborhood Council We held a discussion about whether the Neighborhood Council can vote in forums such as email, without other neighborhood members present. The conclusion was 'no' - votes can only be taken at scheduled meetings of the Neighborhood Association.

We read some clauses in the bylaws: Article II Sections 3 and 4 which discusses who votes (all members of the neighborhood) and Article V Section 1 which establishes the duties of the neighborhood council.

We agreed we need a bylaw amendment to make it very clear how voting works. Points were made about urgent matters that arise and that need resolution in under one month, such that no regular meeting would be held (Continued on page 2)

an identified grocer, but due to the particulars of their finance package, would not be able to break ground until Winter/Spring 2022, with a likely completion date of Summer 2023. Which is to say, if we end up with Gorman, we'll be hard pressed to avoid a grocery gap.

In summary, we have the latitude to move forward with Rule without negatively impacting Gorman's timeline. Nothing's set in stone, and there are no assurances, but I do feel confident this is our best path forward.

**Budget Redux** – We completed the budget, without the all-night meetings I'd been warned might happen. I sponsored an amendment adding \$500,000 to the city's Affordable Housing Fund, believing as I do that housing affordability is one of our biggest challenges. We have

historically low vacancy rates, which drive up rental rates. It's basically supply and demand, more people wanting to live here than we have room to house. And it's getting worse. Approximately 3000 individuals move to Madison every year and we need to plan for the needs of our growing population.

The amendment passed, thankfully, and so did an amendment I sponsored increasing funding for the Focused Interruption Coalition (FIC), a peer-support network of "violence interrupters" based out of Madison Urban Ministry and Nehemiah Community Development Corporation. FIC's work has contributed to a drastic reduction in homicides, another indication that investments in our public health and the social determinants of crime can lead to increased public safety.

That's all for now. Best wishes for a safe, peaceful, and happy holiday season. ❖

before an action was necessary. We agreed that we likely need a bylaw amendment to handle these cases, and cases where general members are unable to attend meetings and wish to cede their vote to a representative. No such amendments have yet been proposed.

**Truman-Olson Site Update** – Yesterday, the selection committee gave their recommendation on which proposal to accept for the Truman-Olson site, choosing Rule Enterprises. While the Rule proposal doesn't currently include a grocery store, the selection committee has given Rule until January to find a grocer to join the proposal. Discussion was held, with many upset that the selection committee ignored recommendations from South Madison Unite and others. For example - the other developers who replied to the RFP have more Madison experience than Rule. If you want another opportunity to voice your opinion, the recommendation goes before the Finance Committee on Nov 25. If it passes out of Finance, it will come before the whole Common Council on Dec 3.

Use of Ad Space in Newsletter to Support South Madison Unite – Discussion was held regarding the donation of a half-page of advertising space in the Bulletin to South Madison Unite. By unanimous vote, we agreed to instead allow P&ED to change their usual column from a text layout to a half-page layout and not donate space to SMU.

## **Committee Reports:**

**Web** – Many of us received an email from Yahoo! Groups about the service changing. To be clear, Yahoo Groups is not going away - just the archival feature which is not in use by BCNA. We'll remain on Yahoo! Groups for the foreseeable future.

**Friends of Olin-Turville** – This winter, the city will be subcontracting brush removal in 3 areas along the railroad tracks and the lakeshore in the park. The city is also starting a new citywide plant life survey, including 2 areas in the Olin-Turville woods and 1 in the prairie area. The city is looking for volunteers to help with plant identification.

The nature walk on December 8 will be about owls.

**Planning & Economic Development** – Mattie Reese intends to open a soul food restaurant at 1610 Gilson St, and has notified us per city regulation about the restaurant and plans to apply for a conditional-use permit. We plan to invite Mattie to the next BCNA meeting to discuss the restaurant.

The city is redeveloping the Oscar Mayer site on the north side. A wetland/green space is located on the property called Hartmeyer Natural Area is over there. Look out for future opportunities to comment on city plans for the site and if the greenspace is kept separate.

**Friends of Monona Bay** – The entire bay was covered by ice during the full moon! It was beautiful, and the earliest in memory that the bay was iced over. A hardy ice fisherman was seen testing the depth with an ice auger.

The next emerging issues meeting of the Neighborhood Association will take place December 12. Reminder that the January 9 meeting is a potluck! ❖

City staff recommended Rule Enterprises for development of the Truman Olson site. Unfortunately he does not have a grocer. A supermarket was the primary purpose of the Truman Olson development. The City is allowing Rule Enterprises until January 16, 2020 to find a grocer.

If Rule does not find a grocery, the City will negotiate with Gorman & Company. Gorman has an agreement in place with Maurer's Markets to build a 24,000 sq. ft. supermarket.

Rule's development will also include up to 150 affordable housing units and 80 workforce housing units that will house about 555 people, including 210 children.

Gorman's proposal includes 79 affordable housing units with 14 market rate units that will house about 190 occupants, 72 of them children.

Rule's proposal will go before the Finance Committee on November 25, 2019 for review and before the Common Council on December 3, 2019. Both of these are public meetings. If you are concerned about the lack of a grocery store, we encourage you to come and share your opinion.



# **FOOT Notes**

I hope you had a chance to enjoy the woods this fall. It is a beautiful time of the year.

There are two interesting projects in Turville



The second project is to begin a long-term plant survey that will be important in measuring any changes in the predominant plant species. This is done by recording all the plants in square meter every 50 meters along a marked transect. That is, on a line between two posts so the survey will be done in the same place each year. The first step is to mark the ends of the transects. We hope to have that done this fall. Starting in the spring there will be surveys along each line. Anyone interested in learning about our plants or helping--like recording what was seen, placing the plot squares, or identifying plants--please let me know at ablattner@charter.net

On the October walk we saw a small bird flapping near the ground. It turned out that the bird was caught in stickseed burrs. This is the plant that will leave lines of very small burrs on the sleeve of your fleece jacket and will really mess up a dog. The bird, probably an Eastern Phoebe, was struggling so we picked it up (that was easy, it was really trapped) and removed the burrs. It was quiet for a while then flew off. Hopefully to continue a happy life. I had never heard of such a thing. I have seen pictures of bats caught by burdocks. Two weeks later there was a report that on the Nature Walk at Cherokee Marsh that they had rescued a Golden-Crowned Kinglet from a thistle. (That little guy got 5 days in a rehab center before he was sent off.) What a coincidence!! The Bird and Nature walks can be exciting.

I reached out to the Wisconsin birding network for more information. Of the four responses, one reported that the bird freed himself; the others were found dead. Two were kinglets! So, it seems to be a very uncommon event.

The next walk in Turville Point Conservation Park is on December 8th from 1:30 to 3.00. Bev Cann will lead. The topic is "Whoo's That?" There is a good chance of hearing a Great Horned Owl. Of course, we hear them very frequently in our neighborhood, but a walk on a winter day is always a good thing. The first walk of 2020 will be on January 12. There may be snow to talk about. Make it a New Year's resolution to take more walks in our beautiful parks and green spaces.
